The Client Portal is integrated with Vestio, the core wealth management system, to simplify the real-time control, analysis, and monitoring of the portfolio.

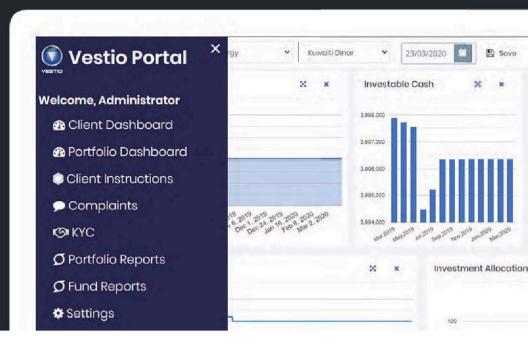

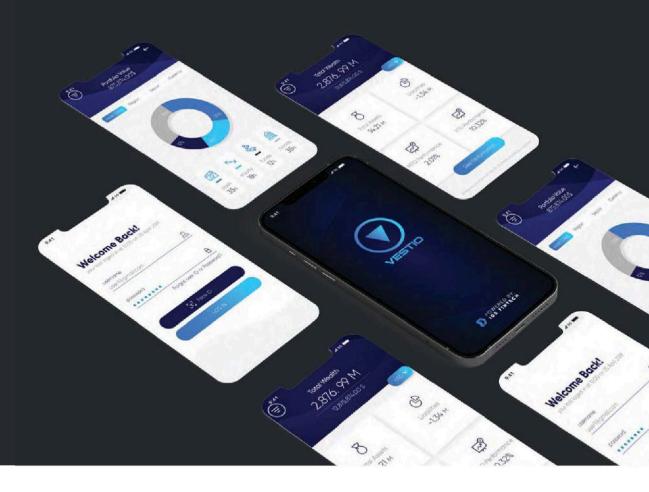

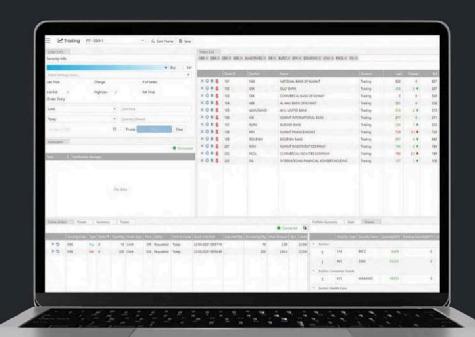
